The multiple cause of death data are not available for all of the out-of-State deaths of Arizona residents, therefore the diabetes-related deaths are understated. All mortality rates are age-adjusted to the 2000 U.S. standard and expressed per 100,000 population. The age-adjustment standard for chronic lower respiratory disease uses the weights for three age groups among persons 45 years or older (45-49 years, 50-64 years, and 65+ years). The incidence rates of reported new HIV/ AIDS cases are based on numerators provided by the Office of HIV/AIDS Services, Bureau of Epidemiology and Disease Control (see Table 5F-3).
